2. The Company had issued 121,454,927 Optionally Convertible Cumulative Preference Shares ('OCCRPS'). These OCCRPS are held by one of the promoters of the Company and four banks.

3. In the column 'No. of Shares Underlying Outstanding convertible securities (including Warrants)', actual no. of Shares that will be allotted to OCCRPS holders have been mentioned on the assumption of full conversion of OCCRPS.

4. In the column 'Shareholding as a % assuming full conversion securities (as a percentage of diluted share capital)', the percentage is arrived at taking the conversion price of Rs. 1112.03 (i.e. Conversion Price of Rs. 1112.03 is as on 4th June 2016, which is Relevant Date). Hence, the denominator for the purpose of calculation of percentage in this column is the enhanced Capital (i.e. Total No. of Fully paid up Equity shares held as on 30/09/2017 plus Equity Shares that will arise assuming full conversion of OCCRPS)
