FAMILIARIZATION PROGRAMMES FOR INDEPENDENT DIRECTORS

Preamble:

Familiarization process/module

The programmes / presentations shall also familiarize the independent Directors with their roles, rights and responsibilities.

Frequency of programme

Familiarization programme will be conducted "as needed" basis during the year.
